No additional hardware / software infrastructure is required for executing and operation this applications module.






To operate this capability, user will have to follow the following steps:

- 1. Execute **Tally.ERP 9** and select the required Company.
- 2. Go to F11: Features (Inventory Features) & `Enable Terms & Conditions in Inventory Vouchers'
- 3. Go to Gateway of Tally > Inventory Info > Terms & Conditions > Create







4. Type the name of the Template for your easy understanding and set the **Terms & conditions** to '**YES**'.




5. Once the **Terms & Condition**s is set to **'YES'** a screen appears for you to Type the relevant terms and save the same as a template.



6. When any inventory based entry are made before it could be saved a pop up screen appears to select the relevant template which are predefined in order to attach it as an annexure in your print.



- 7. Once an inventory based entry is made and print command is given, first the inventory voucher prints and secondly the **Terms & Conditions** is printed as an annexure.

Based on the Template selected, predefined terms will get auto filled, if required the same can be modified at voucher level also and it will get printed for that particular voucher.

Can we get Terms and Conditions for Accounting entries also?

No, the Terms and conditions can be printed for inventory vouchers. But the same can be customized so as to print for accounting vouchers also.
