Advanced Credit Limit

Introduction

This Add-on will enable user to restrict generation of the Delivery Note as well as the Sales Invoice, based on the credit limit amount as specified in the Customer Master.

You can also see the bills outstanding details of that particular customer from the voucher entry itself, instead of navigating from **Gateway of Tally** to the customer ledger account outstanding details section.

Important!

As a best practice it is advisable to take back up your company data before installing the Add-on

Setup Guide

1. Activate the Add-on

For Tally.ERP 9 Series A version lower than Release 3.2

Go to **Gateway of Tally > F11: Features > Accounting Features**

Set "Yes" to the options "**Enable Advanced Credit Limit**"

For Tally.ERP 9 Series A Release 3.2 and above

Go to **Gateway of Tally > F11: Features > Add-on Features**

Set "Yes" to the options "**Enable Advanced Credit Limit**"

2. Add-on details with images.

In Tally.ERP 9, Key in the Credit Limits for the Customer Ledger.

Go to **Gateway of Tally** → **Accounting Info** → **Ledger** → **Single Ledger** → **Alter**

In Tally.ERP 9, Key in the Transactions

Go to **Gateway of Tally** → **Accounting Vouchers** → **Delivery Note**

As soon as the customer is selected, you can see a popup menu which will show the number of overdue bills, if any, related to that particular customer, as shown below:

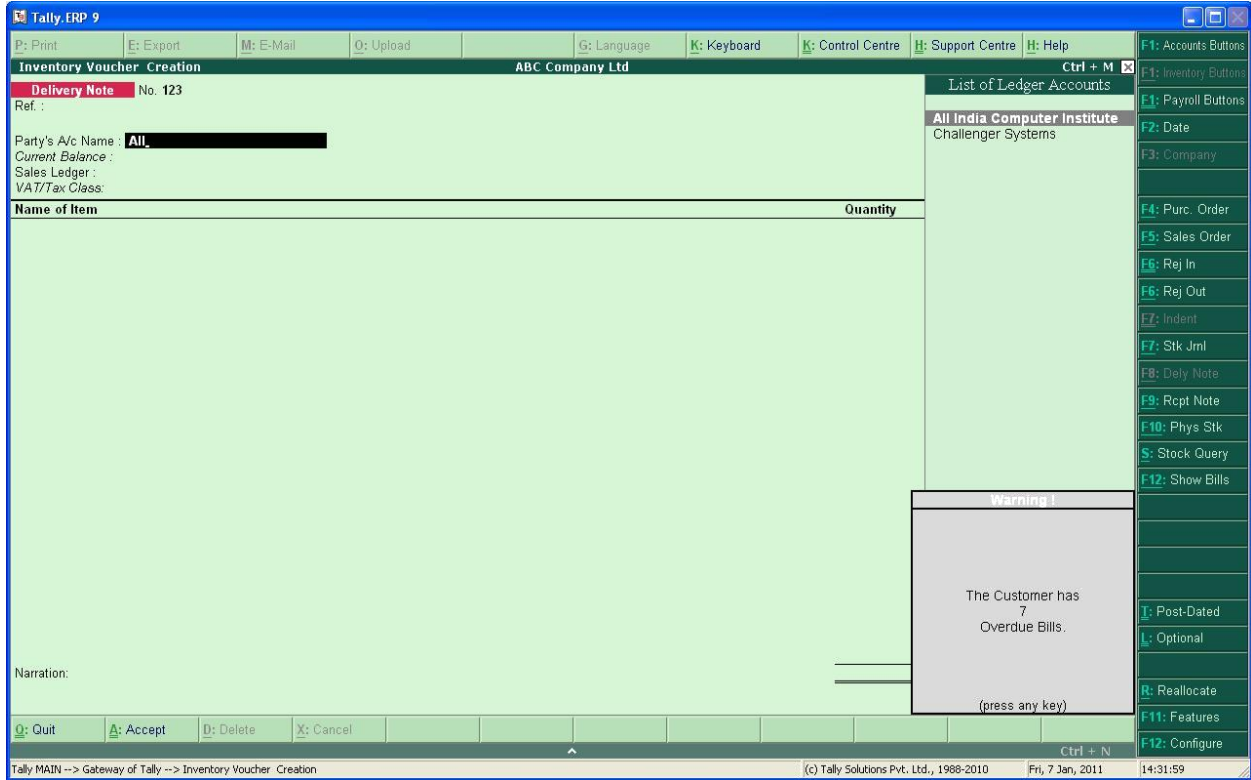


Figure 2: Inventory Voucher Creation

By clicking the **Show Bills** button on the button bar at the creation level of the Delivery note itself, you can see the bills outstanding of that particular customer as shown below:

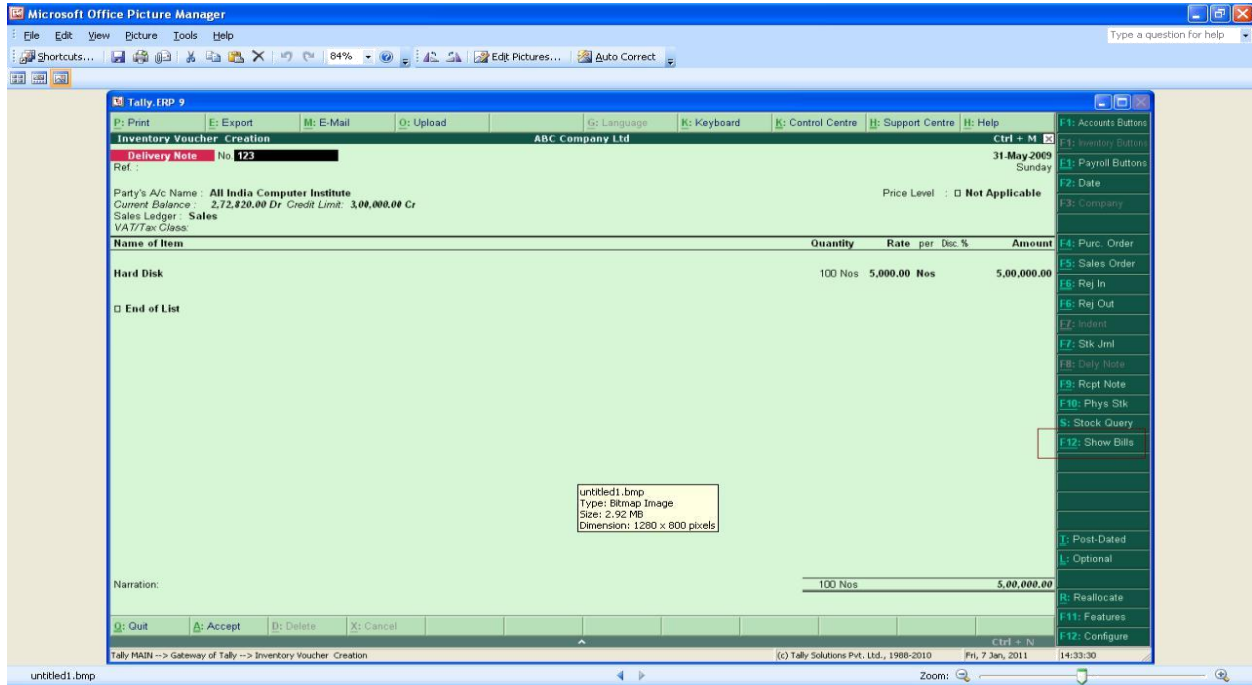


Figure 3: Inventory Voucher Creation: Show Bills

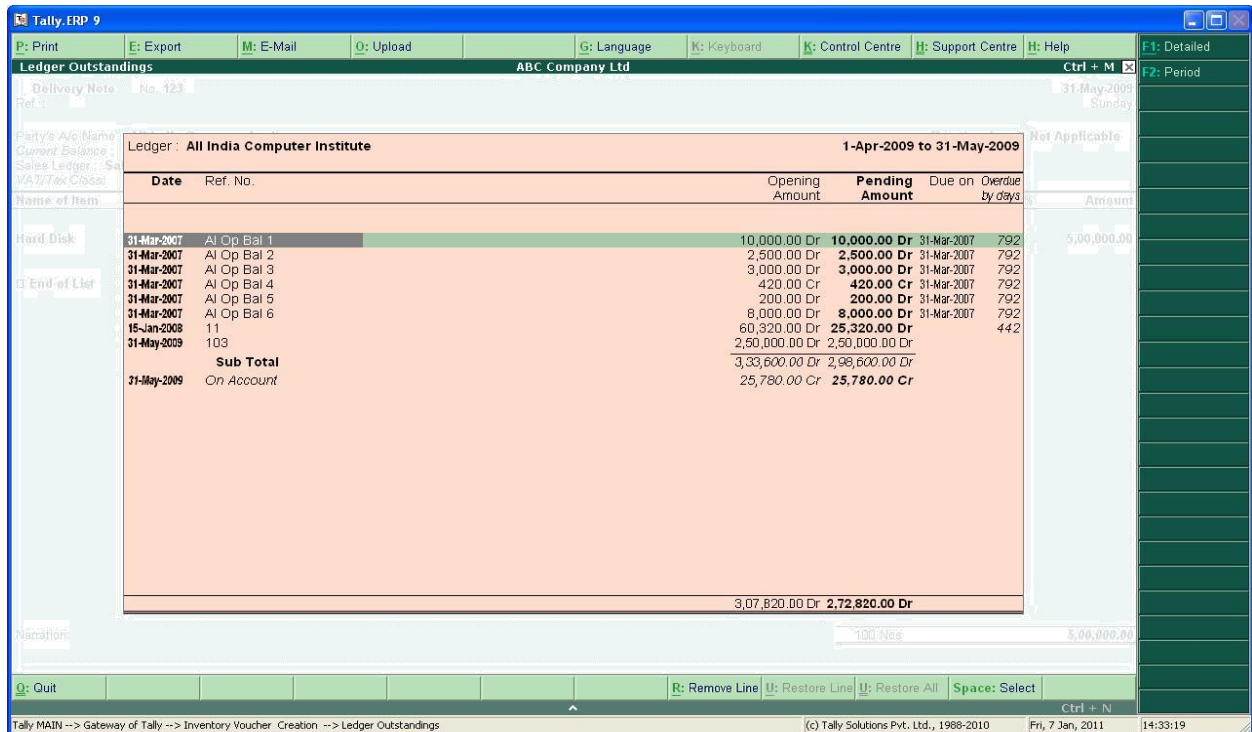


Figure 4: Ledger Outstanding

At the time of saving the entry, the credit limit will be verified with the voucher. In case the limit is exceeded, the following popup message is shown and you will not be able to save the voucher.

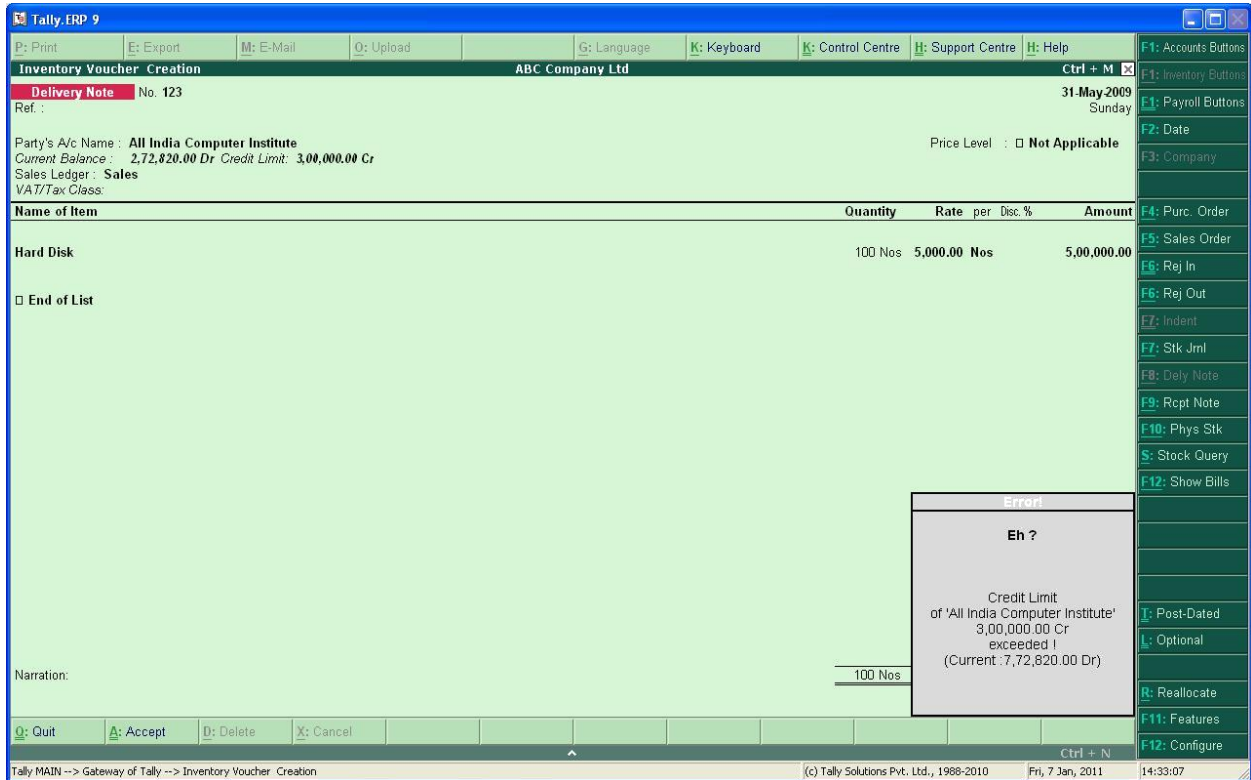


Figure 5: Inventory Voucher Creation
